Inter University Accelerator Centre (IUAC), an Autonomous Centre of University Grants Commission under Ministry of Education, Govt. of India. invites application from qualified Indian Nationals for the position of Junior Engineer (Civil) purely on contractual basis.

**Details of eligibility conditions:**

- (1) Name of Post: – Junior Engineer (Civil)
- (2) Number of Post: – 01 (one)
- (3) Essential Qualification: – Diploma in Civil engineering (3 years regular course) from institute recognized by UGC/AICTE/Technical Education Board.
- (4) Experience: – At least three (03) year's work experience in Civil Construction/Maintenance. Candidate should be aware of software such as MS Office, AutoCAD 2D/3D and well versed with CPWD manuals.
- (5) Upper Age Limit: – Preferably below 30 years on the closing date of application.

**Pay:** Consolidated remuneration of Rs. 40,000/- Per Month.
