Inter-University Accelerator Centre (IUAC), invites online bids through e-Procurement Portal under single bid system, viz., Technical and Financial bids together, from eligible and selected parties for the "Semi-automatic Grinder/Polisher having option for front control with touch button."

Bids shall be submitted online only at CPPP website: http://eprocure.gov.in/ eprocure/app. Bidders /Contractors are advised to follow the instructions provided in the e-procurement portal. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.

IUAC reserves the right to accept / reject any/all tenders in part/full without assigning any reasons thereof.

Bidders have to select the payment option as "offline" to pay the tender fee and EMD as applicable. The Earnest Money Deposit (EMD) and tender cost shall be in the form of demand draft issued in favour of "Inter University Accelerator Centre, New Delhi" and it should be deposited at IUAC before the bid opening. Bidders registered with MSME / NSIC and foreign bidders quoting directly are exempted from payments of EMD and tender fee. Copy of valid registration certificate should be uploaded in the website https://eprocure.gov.in/eprocure/app.

Bidders are requested to note that they should necessarily submit their financial bids in the Standard .XLS BOQ Format provided with this tender document. The same is to be downloaded and to be filled and submited it online without any modification. If the BoQ file is found to be modified by the bidder, the bid will be rejected.

GENERAL Terms & Conditions:

- 1. <u>Submission of Bid</u>: Tenders should be uploaded on CPP Portal in Single Bid mode along with Price Bid.
- 2. The bidder should upload scanned copies of following documents:

A copy of this NIT document fully signed and stamped as acceptance of all terms and conditions.

Price Bid/BOQ in .XLS format

3. Price Bid: In this bid the bidder is required to quote his item rates/prices for the items mentioned in the Annexure- I, i.e. the rates/prices should be inclusive of all material cost, packing and forwarding charges, freight charges & insurance charges upto IUAC. The quoted prices should be excluding GST. IUAC is exempted from GST and necessary exemption certificate will be provided.

4. Earnest Money Deposit:

An earnest money of Rs 7,000/- (Rupees seven thousand only) has to be submitted at IUAC before

opening the bids. The EMD shall be only in the form of bank draft payable to <u>Inter - University Accelerator Centre payable at New Delhi</u>. Tender without EMD will be rejected. **Bidders registered with MSME / NSIC and foreign bidders quoting directly are exempted from payments of EMD and tender fee.** Copy of valid registration certificate should be uploaded.

EMD of technically disqualified bidders will be returned within 15 days from the date of evaluation of the technical bids. The refund of EMD to the unsuccessful bidders shall also be returned within 15 days from the date of opening of price bid. The EMD of the successful bidder (L1) shall be held back as security deposit and will be released only after successful completion of the works/supply.

- **5. Validity of Tender:** Tender shall be valid for our acceptance without any change in rates and NIT conditions for a period of 60 days from the date of opening of price bid.
- **6. Escalation:** No escalation over and above items rates quoted by the bidder shall be paid during the execution of contract.
- 7. Completion time: The time shall be the essence of this contract and all items mentioned in annexure1 is to be completed in all respects within a period of three (3) months from the date of issue of LOI / Purchase order by the centre. Any delay in delivery of items for reasons attributable to the Contractor is liable to deductions on account of Liquidated damages @ 1% of the contract value per week will be deducted subject to a maximum of 10% of the total works. Under the force-majeure conditions or delay due to reasons beyond control of the contractor, IUAC may grant suitable time extension for which the contractor has to request along with the justification/ reasons well in advance to the Director, IUAC for approval without any prejudice to price escalation. No time extension request shall be considered after the expiry of completion period/contract. The decision of the IUAC, Director will be final and binding on the bidder/contractor.
- **8. Scope of Work**: Detailed scope of work, Special terms and conditions, Technical specifications / Makes of materials etc. are enclosed with this NIT as per Annexure I.
- **9. Warranty:** The instrument should be under warranty for a period of one year. Any component defects and material defects within this warranty period has to be repaired/replaced by the bidder free of cost.
- 10. **Deviations:** No deviation from the stipulated terms and conditions will be allowed. Tenders should be unconditional
- **11.** Correspondence: All the correspondence in respect of tender/ contractual obligation shall be made to **A.O.(S&P)**, Inter-University Accelerator Centre, Post Box-10502, Aruna Asaf Ali Marg, New Delhi-110067.
- **12. Terms of Payment:** The payment shall be made on submission of the bills by the vendor after due certification by the IUAC person responsible for supervision of the work. Payment will be released after successful testing and installation at IUAC. All payments shall be made after deduction of income tax at source and work contract tax applicable from time to time.
- 13. **IUAC reserves the right** to reject any or all the tenders in full or in part without assigning any reasons whatsoever, and the decision of the Centre in this regard will be binding on all the bidders.
