## Applicants must satisfy the following eligibility criteria:

- (a) The candidate must have Ph.D. Degree in Archaeology/Geology/Environmental Science or relevant areas with a proven track record of research in the form of publications. Candidates who have submitted their Ph.D. thesis are allowed to apply. However, their candidature will be provisional subject to submission of Ph.D. Degree within the stipulated time.
- (b) The applicants must have scored a minimum of 55% aggregate marks (or equivalent grade) in master's degree in Archaeology/Geology/Environmental Science or relevant subjects.
- (c) The applicants must have studied Geology/Geophysics/Archaeology as the relevant areas mentioned above in their Master's degree.
- (d) Proficiency in the use of variety of computer applications.

### Selection Procedure

A Walk-in Interview will be conducted in the offline mode on 11<sup>th</sup> June, 2024 at 11:00 hrs. onwards at IUAC, New Delhi.

## **Important points**

1. The above position(s) is/are purely temporary and initially for 1 year and is co-terminus with the project. The services of appointed candidates will stand terminated automatically after expiry of the project. The candidate will not have any right for absorption in IUAC.

- 2. The Selected candidates will be required to join the Centre within one month of announcement of result.
- 3. The upper age limit is relaxable as per Govt. of India norms.
- 4. Eligible & desirous candidates are advised to bring their updated C.V. along with one recent passport size photograph, original educational certificates (matriculation onwards) along with Xerox copy & experience certificate of relevant subject (as per advertisement) for appearing in walk-in-interview comprising written-cum personal interview on prescribed date, time and place.
- 5. Candidates should come prepared along with a power point presentation to present the proposed research plan in the advertised stream and using the geochronology facilities at IUAC.
- 6. The research associates will be working under the mentorship of project PI/Co-PI and their primary responsibility will be to provide the support in running the experimental facilities, development of new protocols and research methods to establish chronology and to pursue the proposed research in related domain.
- 7. Director, IUAC reserves the right to increase/decrease the number of position and also to cancel the recruitment process for the position mentioned above. Director's decision will be final and binding in all aspects.
- 8. No TA and DA for appearing in the interview are admissible.
- 9. No candidate will be entertained strictly after 10:30 AM.
- 10.If currently employed, then the candidate will have to furnish no-objection certificate (NOC) from the current employer for appearing in the walk-in-interview.
- 11. Canvassing in any form will render the candidate disgualified for the position.
- 12. Degree should have been awarded by UGC/AICTE recognized University /Institute.
- 13. Eligibility of a candidate for the post applied shall be considered as on the date of walk-in-interview.
- 14. Decision of the Centre in all matters relating to the eligibility of the candidate and selection shall be final and binding on all the candidates. No correspondence or personal inquiries in this regard shall be entertained.
- 15. Centre shall verify the antecedents or documents submitted by candidates at the time of appointment or during the tenure of the service.
