GENERAL CONDITIONS OF TENDER:

1. Submission of Tender_: Tender should be uploaded on CPP Portal. No other mode of submission will be accepted. Any clarifications / amendments / corrigendum etc., to NIT before last date of submission of bid will only be available on our website: www.iuac.res.in. Therefore bidders are advised to keep visiting our website.

2. Technical Bid (Part A): In this bid, the bidder should upload his company profile, history and structure of firm.

The following essential documents are required for technical qualification:

(a) EMD online self attested receipt / NSIC / MSME Exemption Certificate. The bids without Earnest Money Deposit shall be summarily rejected.

b) GST Registration Certificate

c) Proforma For Furnishing Bids (Annexure V)

d) Tender acceptance letter (attached Annexure - VI) on bidder's letter head duly signed & stamped by the bidder as acceptance of all terms & condition of tender.

e)Undertaking letter (attached Annexure – VII) on bidder's letter head duly signed & stamped by the bidder shall be submitted. It is mandatory that the bidder should visit to IUAC and inspect the material before submitting his offer. No compensation for what so ever account will be entertained later on.

f) Bidders must be registered as a Recycler / Reprocessor / Dismantler with Central Pollution Control Board, Ministry of Environment and Forests, Government of India or with the State Pollution Control Board or State Governments. Bids received from the firms other than so registered will be summarily rejected.

3. Financial Bid and Evaluation of Bid (:

Finacial Bid should be quoted in BOQ format the total price should be inclusive of all Misc. charges like transportation. Labour, GST or any other expenses etc.. bidder should fill prescribed format as per Annexure-I. Unstamped and/or unsigned bids will not be entertained.

- (a) The Financial bid of only those bidders shall be evaluated who fulfill the eligibility criteria.
- (b) Any overwriting of/on amount quoted will render the bid to be invalid.
- (c) GST or any other tax/duty, if applicable shall be borne by the bidder.
- (d) The rate quoted shall be final.
- (e) The successful bidder shall be evaluated on the basis of highest quoted price.

- f) It is preferred on bidder to quote all item rates as asked for in the BOQ / PRICE schedule. However part bidding is also accepted. The bidders should quote unconditional rates. Multiple Orders may be placed in parts / item wise to the highest bidder of each item.
- 4. **Prices :** The rates/price quoted should be for the items on "As is where is basis" Ex-IUAC basis. Shifting, loading / unloading, transporting of all the material from IUAC to bidder place, duties, taxes etc. will be in the bidder's scope. No claim / compensation regarding working / non working / condition / quantity of scrap items is admissible under any circumstances.

Price quoted shall be inclusive of GST. However IUAC will not provide any bill / GST invoice for the same. Only money receipt and material out Gate Pass will be provided for the material for disposal as scrap.

5. EMD: Earnest Money Deposit of Rs.20,000/- (Rupees Twenty thousand only) in the form of online payment: <u>https://services.sabpaisa.in/pages/iuac.html</u> before the opening of technical/financial bids. The copy of the payment receipt should be attached along with tender document on or before bid opening date/time as mentioned in critical date sheet. The bidder shall submit a self attested copy of EMD online transfer.

The EMD should remain valid for a period of 45 days beyond the final tender validity period. No interest shall be paid on the earnest money deposit. The refund of EMD of the successful highest bidder shall be released after site clearance.

Bidders shall not be permitted to withdraw their offer or modify the terms and conditions thereof. In case the bidder fails to observe and comply with the stipulations made herein or backs out after quoting the rates, the aforesaid bid security shall be forfeited to the Government.

- 6. **Exemption from EMD:** No exemption is acceptable except NSIC/MSME.
- 7. Validity of Tender: Tender shall be valid for our acceptance without any change in rates and NIT conditions for a period of 120 days from the date of opening of price bid.
- **8. Completion time:** The successful bidder shall make full payment within seven days of bid confirmation . The material will be allowed to take out only after full payment is made.
- 9.. No damage should be caused to the existing property of IUAC while removing the auctioned articles from the site. Any loss/damage to the IUAC or injury or personal accident suffered by any person due the negligence or action of the successful bidder or his authorized worker/supervisor will have to be indemnified by the successful contractor/bidder.
- Delivery Period : Material will be cleared in two parts approximately as below :
 Part-I: Immediately Chillers 4 nos, Pumps 7 nos, All spares / Hardware, Pump / Chiller cables.
 Part-2: After one month Pumps- 3 nos, electrical panel, control desk.

11. Scope of Work : Detailed terms and conditions, scope of work, Annexure – I to V etc. are enclosed with this NIT.

12. Deviations: No deviation from the stipulated terms and conditions will be acceptable. Tenders should be unconditional.

13. Site Conditions : Contractor shall acquaint himself fully with the site conditions and the working environment of IUAC before quoting his rates. No Compensation on account of any site difficulties will be entertained, at a later date, after award of the works.

14. Correspondence : All the correspondence in respect of tender / contractual obligation shall be made to A.O.(S&P), Inter – University Accelerator Centre, Aruna Asaf Ali Marg, New Delhi-110067.

15. Labour Laws: The contractor will abide by all the rules and regulations related to labour laws, accident, workmen compensation act, workmen insurance, ESI, EPF, etc. This will be the sole responsibility of the contractor. IUAC will not be a party at any stage in any of the disputes relating to the above. In case, any liability arises due to non-conformance by the contractor, under no circumstances IUAC will be liable for the same.

16. Rules governing the Contractor's employees working in the IUAC Premises: The contractor's employees working inside the IUAC campus will abide by the IUAC conditions. Any damage to the IUAC property due to mishandling, carelessness on the contractor or his workman part will be recoverable from the contractor's bills.

17. Tender rejection : IUAC reserves the right to reject any or all the tenders in full or in part without assigning any reasons whatsoever, and the decision of the Centre in this regard will be binding on all the bidders. Tenders not complying with any of the provisions stated in this tender document are liable to be rejected. **Director, IUAC reserves the right to accept or reject any tender without assigning any reason and does not bind himself to accept the lowest tender.** Issue of bid documents does not automatically mean that the bidder is considered for the bid. No claim towards rejection will be considered.

18. Gate Pass: All the persons deployed by the bidder at IUAC site will have to carry valid gate passes. Any negligence/offense on their part will attract immediate removal from site.

19. The successful contractor will provide for all necessary man power, materials, tools, equipment, etc. needed for removal of the material

20. Watch and Ward of all material till it, s taken out shall be the sole responsibility of the contractor and pilferage etc. shall be entirely to his account.

21. All the employees will have to be covered under insurance against any personal accident and IUAC will not be liable for payment of any compensation on that account.

22. During execution of work, the contractor should follow all standard norms of safety measures / precautions to avoid accidents / damages to man, machines and buildings. Non-adherence of this clause, suitable fines, as decided by the Director, IUAC shall be imposed.

23. IUAC will provide free water and electricity during work at IUAC, at one point. The contractor has to make his own arrangements for installation of power and water from that point as per his requirements.

24. Tender once submitted will remain with the centre and will never be returned to the bidders.

25. Termination of Contract: The Director, IUAC reserves the right to terminate the contract on account of poor workmanship, failure to mobilise the site within 30 days, non-compliance of set norms/ specifications for the works, delay in progress of work, violation of any contract provisions by the contractor. In such case the contractor EMD shall be forfeited.

26. Resolution of Dispute: All disputes arising out of this contract shall be referred to the sole arbitration of a person selected by the contractor out of the panel of three persons nominated by the Director IUAC, and his decision /award shall be final and binding on both parties. The Arbitration shall be governed under the Indian Arbitration Act 1996 or any statutory modifications or reenactment thereof and rules made there under and for the time being in force shall apply to the arbitration proceeding under this contract. Any dispute arising out of this contract will be subjected to jurisdiction of New Delhi/Delhi.

1. Introduction

The work involves sale of disposal of old / obsolete / scrapped HVAC machinery on as is where is basis as per list (Annexure-I, & II).

2. The scope of work:

- a) All the material / machinery may not be available at the same time. As the some machines are part of the running system, so there removal from the foundation / system subject to the availability of the shut down. The same will be allowed for removal as and when the plant shut down is available. No compensation on this account will be admissible on account of extra manpower, transport, crane cost etc. The bidder should take this in account while quoting.
- b) The machinery will be removed from the foundation / system by the HVAC contractor of the IUAC. Same shall be taken over by successful highest bidder from IUAC from the running system.
- c) The machinery may be removed from the foundation in dismantled or assembled condition as per the site condition. The successful bidder will have no choice to have the machinery in the dismantled / assembled condition but as per the condition after dismantling.
- d) Please note that all machines are on offer for sale from their in / out end flange. No piping, fittings, flanges, valves etc. will be provided for disposal.
- e) The successful bidder may have the option to take up the removal / dismantle work at his cost and risk, if agreed upon by all the parties i.e. IUAC, HVAC contractor and successful bidder.
- f) IUAC will have no responsibility for the watch and ward of the machinery / material once dismantled and clearance for the removal is given.
- g) The site should be cleared of material within one week of clearance by IUAC, failing which the bid money will be forfeited and no further claim will be entertained.
- h) While quoting the price the bidder shall make it,s own inspection, judgment and decision about the quantum / condition of the items. IUAC is not responsible for the same.
- i) The site shall be cleared of debris items like cement, insulation material, plastic etc. removed from the machinery.
