- 2. The disposal of vehicle shall be strictly on " AS IS WHERE IS BASIS" and no guarantee or certificate of its worthiness or quality will be given by the Centre.
- 3. The condition of the vehicle can be inspected physically between 02.30 pm to 5.30 pm on any working day between 22.07.2019 to 26.07.2019 at IUAC by contacting Shri K.Murali, AO(E), IUAC, Aruna Asaf Ali Marg, New Delhi -67. (Phone No.011-24126018 & 22 (ext.204).
- 4. Earnest money for Rs.10,000/- can be deposited by Bank Draft in favour of "Inter-University Accelerator Centre", payable at New Delhi before opening of bids.
- 5. The successful bidder will be required to deposit the total bid amount by means of Demand Draft/Pay Order/Banker's Cheque in favour of "Inter-University Accelerator Centre", New Delhi within three working days of award of the offer.
