Inter - University Accelerator Centre (IUAC) invites online bids on behalf of the Director IUAC, New Delhi through e-procurement Portal under two bid system, viz., Technical and Financial bids, from eligible / experienced parties for the supply of a 50kW DC power supply for 28kW RF Power Amplifier as per Annexure A".

Tender Documents may be downloaded from Central Public Procurement (CPP) Portal free of cost https://eprocure.gov.in/eprocure/app. Aspiring Bidders who have not enrolled/registered in e-procurement portal should enroll/register before participating through the website https://eprocure.gov.in/eprocure/app. Bids should be submitted online only at website: https://eprocure.gov.in/eprocure/app. Tenderers / Contractors / Bidders are advised to follow the instructions provided in the e-procurement portal. Bid documents may be scanned with 100 dpi with

black and white option which helps in reducing size of the scanned documents.

IUAC reserves the right to accept / reject any / all tenders in part / full without assigning any reasons whatsoever, and the decision of IUAC in this regard will be binding on all the bidders.

Bidder has to select the payment option as "online" to pay the EMD as applicable by going to the link https://services.sabpaisa.in/pages/iuac.html . The Earnest Money Deposit shall be in the form of online payment and it should be deposited before the bid opening. Bidders registered with MSME/ NSIC are exempted from payments of EMD. Tenderers registered with MSME/NSIC (the unit being registered for the item/work tendered) are required to upload copy of valid registration certificate in the website https://eprocure.gov.in/eprocure/app along with technical bid.

If the price bid has been given as a standard .XLS BOQ Format with the tender document, then the same is to be downloaded and to be filled and submitted online without modifying the format. If the BOQ file is found to be modified by the bidder, the bid will be rejected.

INSTRUCTIONS TO BIDDERS

REGISTRATION PROCESS ON CPP PORTAL FOR ONLINE BIDDING

Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: https://eprocure.gov.in/eprocure/app) by clicking on the link "Online Bidder Enrolment" on the CPP Portal which is free of charge.

Bidder who registered already may skip the registration process and login to site through their user ID/Password

- As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4 Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra/ Nic etc.), with their profile.
- Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- 6 Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC / e-Token.

SEARCHING FOR TENDER DOCUMENTS

There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, Organization Name, Location, Date, Value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of

search parameters such as Organization Name, Form of Contract, Location, Date, Other keywords etc. to search for a tender published on the CPP Portal.

- Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective 'My Tenders' folder. This would enable the CPP Portal to intimate the bidders through SMS / e-mail in case there is any corrigendum issued to the tender document.
- 3 The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification / help from the Helpdesk.

PREPARATION OF BIDS

- Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF/JPG formats. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, GST Certificate etc.) has been provided to the bidders. Bidders can use "My Space" or ''Other Important Documents' area available to them to upload such documents. These documents may be directly submitted from the "My Space" area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

Note: Bidder should take into account any corrigendum published on the tender document before submitting their bids.

INSTRUCTIONS FOR SUBMISSION OF BIDS

- 1. The tender documents are available on our website www.iuac.res.in & www.eprocure.gov.in.
- 2. Tender documents may be downloaded from IUAC's website www.iuac.res.in and CPPP site https://eprocure.gov.in/eprocure/app as per the schedule as given in the tender document.
- 3. The tender shall be submitted online in two parts, viz., Technical bid and Financial (price Bid)bid.
- 4. The offers submitted by hand/Post/Fax/email shall not be considered. No correspondence will be entertained in this matter.
- 5. All the pages of bid being submitted must be sequentially numbered by the bidder irrespective of nature and content of the documents before uploading.
- 6. The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the

CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

- 7. Bidder should log into the site well in advance for bid submission so that they can upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- 8. The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- 9. Bidders are requested to note that they should necessarily submit their financial (price Bid) bids in the format provided and no other format is acceptable. If the price bid has been given as a standard BOQ format with the tender document, then the same is to be downloaded and to be filled by all the bidders. Bidders are required to download the BOQ file, open it and complete the white coloured (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BoQ file is found to be modified by the bidder, the bid will be rejected.
- 10. The server time (which is displayed on the bidders' dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.
- 11. All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128 bit encryption technology. Data storage encryption of sensitive fields is done. Any bid document that is uploaded to the server is subjected to symmetric encryption using a system generated symmetric key. Further this key is subjected to asymmetric encryption using buyers/bid opener's public keys. Overall, the uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- 12. The uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- 13. Upon the successful and timely submission of bids (i.e. after Clicking "Freeze Bid Submission" in the portal), the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.
- 14. The bid summary has to be printed and kept as an acknowledgment of the submission of the bid. This acknowledgment may be used as an entry pass for any bid opening meetings.
- 15. Not more than one tender shall be submitted by one contractor or contractors having business relationship. Under no circumstance will father and his son(s) or other close relations who have business relationship with one another (i.e. when one or more partner(s)/director(s) are common) be allowed to tender for the same contract as separate competitors. A breach of this condition will render the tenders of both parties liable to rejection.
- 16. The bidders are advised to visit CPPP website https://eprocure.gov.in/eprocure/app at least 3 days prior to closing date of submission of tender for any corrigendum / addendum/ amendment.
- 17. Bids will be opened as per date/time as mentioned in the **Tender Document.** After online opening and evaluation of technical bids, the results of their qualification as well Price-Bid opening will be intimated.
- 18. Submission of a tender by a tenderer implies that he has read all the stipulations contained in this tender document and has acquainted him of the nature, scope and specifications of the items to be followed.

- 19. The tenderer shall submit all documents after duly filling the same in all respects. Tenders which are found to be vague or incomplete shall be rejected summarily.
- 20. Tenders shall be submitted ON-LINE, it shall be signed by one who has been authorized by the board of director /director / manufacture/ firm owner /their authorized agents through a resolution/ authority letter. Copy of the resolution/ authority letter in favor of the person signing must accompany the tender.
- 21. Tenders containing erasures and alterations of the tender documents are liable to be rejected unless these are authenticated by the person signing the Tender Documents.

22. Code of Integrity for Public Procurement

General Terms and Conditions of the Tender:

1. Submission of Tender:

Tenders should be uploaded on CPP Portal in two parts, i.e., Technical Bid (Part - A) and Price Bid / BOQ (Part - B).

2. Technical Bid (Part - A):

Pre-qualification of the bidder

Only Original Equipment Manufacturer (OEM) or their authorized (sales and service) representatives in India are eligible to quote for the required item as per the specification given in Annuexure-A. The authorized representatives will have to submit a valid certificate of authorization from the OEM along with the BID.—The bidder will have to submit OEM technical brochure wherein description of the product lineup including quoted product and company services are clearly mentioned along with required technical specifications.

The bidder must be a national or internationally reputed firm/company/manufacturer or their representative of high current power supplies of various ratings, who have supplied and carrying out after sale services such as repair, restoration, test and calibration for similar type of DC Power supplies to the internationally reputed laboratories and industries worldwide. The bidder will have to submit the document proofs required for the same.

The bidder must be duly authorized by the OEM for power supply repair facilities along with trained manpower, supported by the OEM for spare parts and other required resources for successful repair, restoration, test and calibration in India. The bidder will have to submit the document proof / undertaking from OEM for the same.

No deviations in respect of NIT conditions are acceptable. In this bid, the bidder should upload the following documents:

- 1. Tender Acceptance Letter (written on company letter head, duly signed and stamped.) as per format provide in Annexure B, as a token of acceptance of the NIT conditions, with this bid.
- 2. Profile of the Tenderer as per Annexure C
- 3. Earnest Money Deposit Proof & MSME to submit Bid Securing Declaration in lieu of EMD/Bid Security
- 4. Format for declaration by the Bidder for Code of Integrity & conflict of interest ANNEXURE-D
- 5. Undertaking by the bidder as per Annexure E.
- 6. Declaration of local content as per Annexure F.
- 7. Check list for pre-qualification Bid as per Annexure G.
- 8. Check list Technical Compliance sheet confirming to details given in Annexure-A to be duly filled confirming the technical specifications and service requirements of the product as per Annexure J.
- 9. Valid authorized representatives/dealership certificate with authorization from the OEM.
- 10. The quoted item should be a standard catalogue product, displayed prominently in product catalogue / OEM website. A copy of brochure is to be attached.
- 11. Details (Complete address with contact number) of the authorized service center in India for the quoted product along with a valid undertaking/ certificate from OEM authorizing service facility of their products in India for after sale services such as repair, restoration, test & calibration to be attached.
- 12. Drawings / test results / catalogues / other technical specifications of the products indicating its ability to meet the technical specifications.
- 13. Copy of successfully executed one work order having a minimum value of Rs. 32,00,000/- (Rupees Five lacs) or Two work orders having minimum of Rs.20 Lakhs or Three work orders having minimum of

Rs.16 Lakhs for the supply of similar kind of systems to reputed organizations, Govt. dept., Public sector & Autonomous bodies for minimum qualification in India in the last 5 years. Further, the bidder should have a minimum annual turnover of at least Rs.30/- Lakhs for each of the last three financial years ending March 31, 2021 along with copies of ITRs, of last three years is required.

- 14. Copies of the audited statements/turnover certificate of the past three financial years ending on 31st March of the previous financial year in which the tenders are invited. To support the claim, provide a certificate of CA. In case balance sheet and statement of Profit & Loss for the immediate preceding financial year have not be prepared/audited, the account for one more preceding financial year can be submitted.
- 15. The bidder should not be a blacklisted individual or entity by any Government, or Government Department, whether in the Central/State/District levels across India. An undertaking in this regard as per Annexure-B be enclosed with the Technical Bid.
- 16. The bidder shall assure in written for the supply of spare parts after warranty is over for maintenance of the equipment supplied if and when required for a period of at least two years.

Technical bids which are not confirming to the technical specifications will be disqualified.

3. Price Bid / BOQ (Part - B):

In this bid, the bidder is required to quote unconditional rates in the .XLS BOQ format provided with this tender. Quotes in INR will only be accepted.

The Indigenous suppliers quoting in INR should quote the rates all-inclusive upto IUAC and excluding GST. IUAC is exempted from Customs Duty and GST and necessarily certificates shall be issued by IUAC along with the PO. The BOQ file must not be modified.

The following information to be provide along with Price Bid:

a. Mention that the warranty period which shall not be less than 24 months. Standard accessories and documentation such as manuals, software if any would be provided.

4. Earnest Money Deposit:

Bidder has to select the payment option as "online" to pay the EMD as applicable by going to the link https://services.sabpaisa.in/pages/iuac.html . The Earnest Money Deposit shall be in the form of online payment and it should be deposited before the bid opening. Bid Security shall be refunded to the un-successful bidders on award of contract and to successful bidders on receipt of Performance Security.

EMD is the mandatory requirement however the MSMEs/NSIC registered with Government Agencies are exempted from payment of Earnest Money Deposit (EMD) and are required to submit Bid Securing Declaration subject to conditions given below: -

- i) MSMEs participating in the tender must submit valid & authorized copy of certificate of registration. The MSME's Bidder to note and ensure that nature of services and goods/items manufactured mentioned in MSME's certificate matches with the nature of the services and goods/items to be supplied as per Tender.

6. Escalation / Deviation:

7. Performance Security

9. Terms of Payment:

80% of the payment shall be made after the delivery of all the goods at IUAC. 10% of the total payment shall be made after successful technical inspection, installation, integration and acceptance of all the components at IUAC with due certification by the concerned IUAC personnel. The balance 10% payment would be released on submission of 10% Performance Security in the form of FDR/BG. All payments will be made after statutory deductions.

10. Guarantee/Defect liability period:

13. Force-Majeure:

15. Participation of IUAC Personnel:

The IUAC personnel will witness and participate in the complete process of installation, testing, demonstration and operation of the system at IUAC.

16. Final Acceptance:
